### **MEETING MINUTES**

### III. ITEMS SCHEDULED FOR INFORMATION/ ACTION

- A. The Board shall extend Fernando Tapia's term two additional years. Fernando Tapia's term will expire on January 31, 2017.
  - a. Bobby Butler made a motion to extend Fernando Tapia's term on the board for two additional years. Marianna Rodriguez seconded the motion. All present were in favor. The motion to extend Fernando Tapia's term passed with the following vote:

- B. The Board shall elect officers.
  - a. Bobby Butler made a motion to elect Saul Sarabia as Board Chair, Marianna Rodriguez as Board Secretary and Aurora Rodriguez as Board Treasurer. Marianna Rodriguez seconded the motion. All present were in favor. The motion passed with the following vote:

- D. The Board shall receive a briefing and update on key areas of Clear Passage Educational Center's launch activities and next steps.
  - a. Vivianna Trujillo reviewed recent efforts to identify and secure a suitable location. Ms. Trujillo also shared that the school's realtor is scheduling site visits to possible locations. The Willow site is looking promising. She shared a proposed floor plan for the Willow site. The goal is to secure a site by the third week of February.

Ms. Trujillo shared that a fundraising team has been secured. The fundraising team will focus its efforts on applying to some pre-identified grants as well as helping develop CPEC's fundraising materials.

Ms. Trujillo provided an update on the Community Outreach and Awareness Campaign in collaboration with Centro CHA. Community outreach meetings will start in mid February.

Ms. Trujillo is working on applying for the Charter School Revolving Loan which is due toward the end of February. If granted CPEC will receive approximately \$250,000. The funds are expected to be disbursed in late July or August.

Ms. Trujillo shared that she has been in contact with the Occupational Therapy Training Program. They are aligned with CPEC's mission and are interested in providing CPEC students with mental health services.

Ms. Trujillo shared that she met with the UCLA Community Programs Office and will continue to nurture that relationship.

- E. The Board shall review and approve the minutes of the November 15, 2014 Board meeting.
  - . Bobby Butler made a motion to approve the Board minutes for the November 15, 2014 Board meeting. Marianna Rodriguez seconded the motion. All present were in favor. The motion to approve the previously stated board minutes passed with the following vote:
