Each educational partner was given the opportunity to participate in discussions and provide meaningful consultation regarding instructional support and safety net strategies for students. The educational needs of all students including at-risk students, English learners, children with disabilities, homeless students, probation and foster youth, and other underrepresented students were considered in the planning discussions. Presently, tribal students and migratory students are not enrolled in CPEC.

Stakeholder engagement was facilitated via:

1. Parent/student/teacher conferences.
2. Goal setting meetings.
3. Student Success Team meetings.
4. School leadership and staff meetings.
5. IEP team meetings.
6. Community agency forums (that included foster youth and homeless services partners, and probation department partners).
7. School Board meetings.

Feedback from educational partners was secured via the following consultative actions:

1. Engaged in parent/student/teacher conferences with parents of academically at-risk students, English learners, children with disabilities, homeless students, probation and foster youth, and other underrepresented students to secure input on areas of need.
2. Engaged parents and community partners in virtual community forums to secure input on areas of need of at-risk students, English learners, children with disabilities, homeless students, probation and foster youth, and other underrepresented students.
3. Engaged in discussions with probation department partners to secure input on areas of need of probation youth and children who are incarcerated.
4. Participated in quarterly meetings with partners representing foster youth and homeless services to secure input on the areas of need of foster youth and homeless students.
5. Facilitated staff meetings and virtual professional development for CPEC's teachers, instructional staff, administrative staff and office staff.
6. Presented the plan to the school's Board, parents, community partners and the public at large at the school's Board meeting.
7. Distributed surveys to students, parents, guardians and authorized care givers.

Information related to scheduled meetings/consultative actions was distributed/promoted via email, mailed letters, the school's website and the school's student/parent communication app. Given COVID-related social distancing requirements, all touch points were facilitated via the Internet and phone.

A description of how the development of the plan was influenced by community input.

Clear Passage Educational Center (CPEC) collaborated and received input from the following educational partners that influenced the development of the plan: students, parents, teachers, instructional staff, Special Education district team members, administrative staff, office staff, board members, probation department partners, foster youth and homeless services partners, and community-based agencies.

Stakeholder engagement was facilitated via parent/student/teacher conferences, goal setting meetings, Student Success Team meetings, IEP team meetings, school leadership and staff meetings, community partner forums and school Board meetings. The educational needs of all students including at-risk students, English learners, children with disabilities, homeless students, probation and foster youth and other underrepresented students were considered in the planning discussions.

Community input and feedback included but was not limited to the following:

- 1. Inquiries related to how CPEC would address COVID-related social distancing requirements and student safety.
- 2. Concern related to potential learning loss and a deceleration in student course completion that may have resulted from students temporarily not having access to CPEC's computer lab and onsite learning resources, or in-person access to CPEC's instructional staff during the COVID-19 stay at home order.

The feedback and input secured from CPEC's educational partners influenced the school's decision to include the following expenditures in the plan:

- 1. The procurement of cleaning and disinfectant supplies that prevent the spread of COVID-19.
- 2. The hiring of tutors to provide additional instructional support for struggling students.
- 3. The procurement of additional credit recovery course licenses.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
